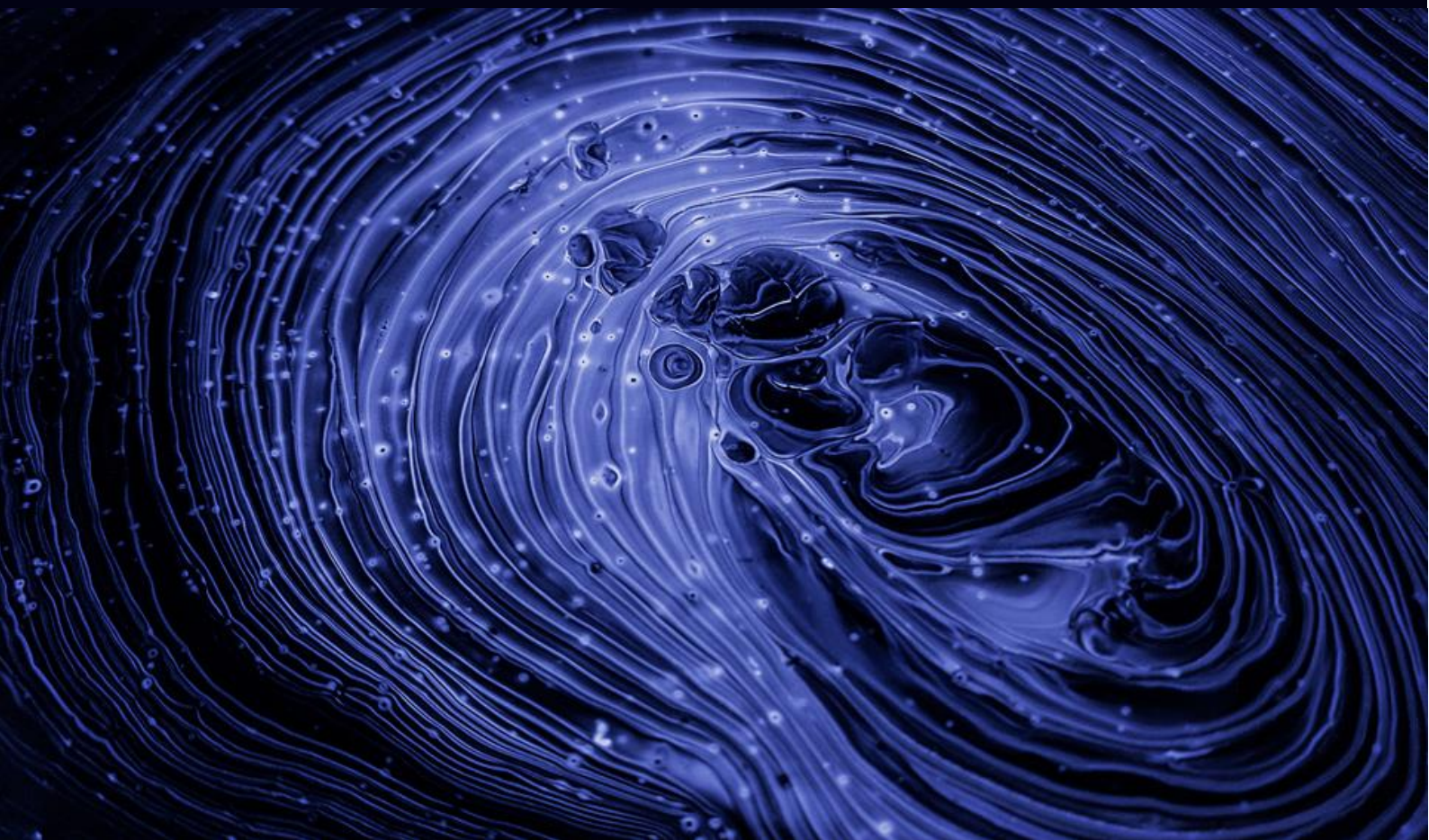

1. Executive Summary

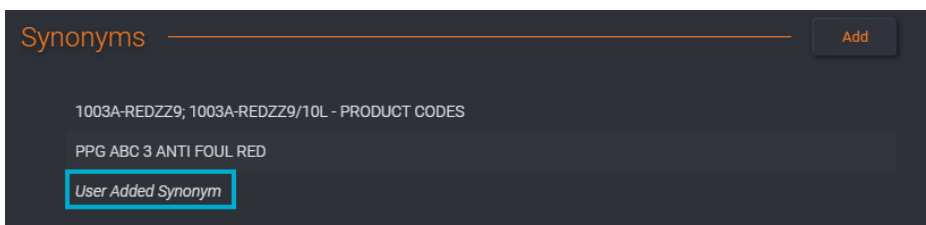
ChemAlert v5.2.1 builds upon the recent 5.2 release, offering a series of minor but impactful upgrades designed to enhance performance, optimise the user experience, and improve the overall efficiency of chemical management.

2. Enhancements and Bug Fixes

2.1 Enhancements

API SOLUTION FOR CUSTOM SYNONYM SEARCHING [44563]

ChemAlert has introduced an API Rest endpoint to enable users to pull a list of user added synonyms for products in the ChemAlert library.

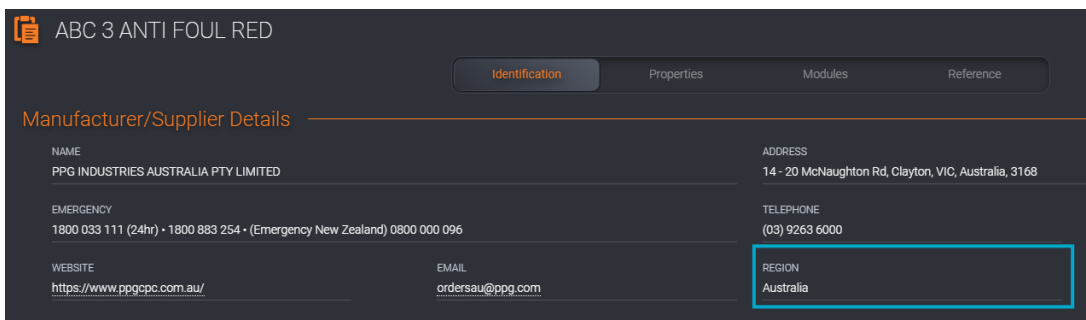


REGIONALISE 'ENFORCE DETAILED RISK ASSESSMENT' BY GHS CLASSIFICATION [44452]

The option to enforce a detailed risk assessment by GHS classification has been modified to display the correct GHS classification listing as per the Business Unit Region.

ADD REGION FIELD TO PRODUCT DETAILS [41650]

Within Product Details, there is a new field which displays the Region of the SDS for the Product. This aligns with the regionalisation of ChemAlert from 5.2 and communicates which region the product information is displayed for.



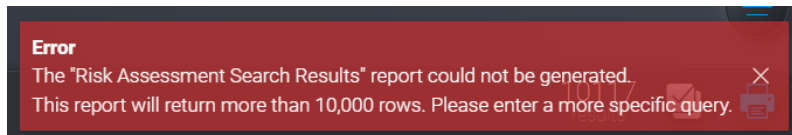
FURTHER FIXES TO AU STORAGE INCOMPATIBILITIES – SUBRISKS [43862]

Further updates have been made in line with AS 3833:2024 to include subsidiary risks.

2.2 Bug Fixes & General Tasks

EXPORTING SEARCH RESULTS FOR MORE THAN 10K RESULTS DOESN'T RETURN A REPORT [44966]

If exporting a list of search results for greater than 10,000 entries, ChemAlert will now display an error to further refine the search to preserve performance.



EMAIL CUSTOM PRODUCT DOES NOT INCLUDE THE COMPANY NAME [44790]

The Company Name in a Custom Product email sent to RMT was missing which has now been reinstated.

ENGLISH TEXT DISPLAYED FOR USER WITH LANGUAGE AS INDONESIA [44444]

Indonesian labels have been reinstated where they previously showed English language.

PRE-SCREENING RESPONSES ON DUPLICATED CHEMICAL REQUESTS DON'T OVERRIDE [43567]

When a Chemical Request is duplicated, the pre-screening responses are now saved as per the newly answered questions.

STOCK REGISTER NOT WORKING AS EXPECTED WITH 'SHOW STOCK REGISTER ONLY' APPLIED IN USER PREFERENCES [36510]

Users with permission to search the 'Stock Register Only' are now able to Search without error, regardless of Group Permissions for access to the Stock module itself.

CANNOT EDIT INVENTORY ITEM CONTAINERS IF CONTAINER TRACKING IS ENFORCED [44530]

Container Tracking is now accessible when Container Tracking is enforced via Business Unit Preferences.

3. Technology and Architecture Changes

Upgraded underlying architecture components to ensure currency, as older versions may have unpatched security vulnerabilities. Upgrades may take place outside of ChemAlert releases to retain such currency.

4. Known Issues

We never let through critical known issues, however as with all software there will be functionality that doesn't fully pass our testing process but is so low impact that we mark it as a known issue.

CUSTOM LABEL BARCODE NOT SCANNABLE UNLESS YOU ZOOM IN [45323]

CA Mobile Users will need to zoom in on custom label barcodes in order to scan.

SAVING GROUPS MULTIPLE TIMES AFTER UNLINKING USER CAUSES THE USER TO REAPPEAR [45305]

Users should be mindful to only save Groups once after unlinking a User to prevent it from reappearing in the list.

DUPLICATE GROUPS WITH THE EXACT SAME NAME CAN BE CREATED [45035]

If more than one Group with the same name is created, ChemAlert will not display an error.
